## Resolution Proposing that Millage Ballot Proposals Shall Appear on the Ballot in November Only

WHEREAS, the cost of Millage elections to the State of Michigan represent a significant expenditure and having low turnout - single issue elections is an inefficient use of the taxpayers money;

WHEREAS, elections held other than in November typically do not have a representative voter turnout to obtain election results that accurately reflect the will of the people on Millage Proposals;

WHEREAS, ballot Millage Proposals held on low voter turnout dates are often used as a strategy by special interest groups to put forth a Millage Proposal when voters typically do not come to the polls;

WHEREAS, elections held in months other than November are often used by special interests to market their proposal to a target audience thereby increasing the turnout of the voters that the special interest believes will vote in favor of the Millage Proposal;

WHEREAS, these ballot proposals should be held at a time when the highest election turnout is anticipated at the November election to be representative of the people's will;

NOW THEREFORE BE IT RESOLVED, the Washtenaw County Republican Executive Committee encourages our state legislators, as well as municipalities, school boards and other local governing bodies in our county and state to adopt resolutions restricting millages and other tax increases to the November election.
